FOR COSTS ASSOCIATED WITH THE FOURTH ANNUAL LOUISVILLE PRIDE FESTIVAL HELD ON SEPTEMBER 15, 2018.

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of \$8,500 is hereby appropriated from Neighborhood Development Funds in the following manner: \$1,500 from District 8; \$1,000 each from Districts 2, 6, and 26; \$500 each from Districts 1, 4, 9, 10, 12, 15, and 25; and \$250 each from Districts 14 and 21; through the Office of

Management and Budget, to Louisville Pride Foundation, Inc. for costs associated with the fourth annual Louisville Pride Festival held on September 15, 2018.

**SECTION II:** The Council has determined that the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
