**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$7,750~~ \$10,750 \$12,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,000 each from Districts 14 and 25; \$2,000 from District 13; \$1,000 each from Districts 15 and 24; and \$750 from District 10; \$500 each from Districts 1 and 23; and \$250 from District 19; to Metro Parks for the 2019 Riverview Independence Festival.

**SECTION II:** The Council has determined that the funds requested in this Ordinance will be expended for a public

purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
