ORDINANCE NO. _____, SERIES 2019

AN ORDINANCE APPROPRIATING \$7,500 FROM DISTRICT 1 NEIGHBORHOOD DEVELOPMENT FUNDS, THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE LOUISVILLE COMMUNITY DESIGN CENTER, INC., DBA CENTER FOR NEIGHBORHOODS, FOR BETTER BLOCKS LOUISVILLE.

SPONSORED BY: COUNCIL MEMBER GREEN

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$7,500 is hereby appropriated from District 1 Neighborhood Development Funds, through the Office of Management and Budget, to the Louisville Community Design Center, Inc., dba Center for Neighborhoods, for Better Blocks Louisville, a temporary intervention that creates walkable destinations, street design, and vibrant public spaces. The requested funds are to be used in Parkland neighborhood at 28th Street from Virginia Ave. to Dumesnil St. and Catalpa St., with assistance from the residents.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
