**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of \$5,099.82 is hereby appropriated from District 18 Neighborhood Development Funds to Solid Waste Management Services to fund a junk drop off and electronics recycling event at the University of Louisville's Shelby Campus held on April 6, 2019.

**SECTION II:** The Council has determined the funds requested in this ordinance will be expended for a public purpose.
