FOR PROGRAM EXPENSES ASSOCIATED WITH THE 16TH ANNUAL KEN-DUCKY DERBY (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$7,750 \$8,750 \$9,500 is hereby appropriated from Neighborhood Development Funds in the

following manner: \$4,000 from District 12; \$1,000 each from Districts 13 and 25; \$750 from District 14; \$500 each from

Districts 1, 2, 3, 21, and 22; and \$250 from District 6; through the Office of Management and Budget, to Harbor House of

Louisville, Inc. for program expenses associated with the 16<sup>th</sup> annual KenDucky Derby.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public
