BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$2,000~~ \$8,150 \$11,300 is hereby appropriated from the Neighborhood Development Funds in the following manner: ~~\$2,000~~ \$4,000 from District 22; \$1,000 each from Districts 4 and 19; \$500 each from Districts 1,

16, and 21, 25, and 26; \$300 from District 14; \$250 each from Districts 2, 3, 6, 12, 13, 15, 16, 17, 20, and 23; and \$100 from District 3; through the Office of Management and Budget, to Junior Achievement of Kentuckiana, Inc. for curriculum materials.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
