BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$2,500~~ \$7,250 \$8,250 is hereby appropriated from Neighborhood Development Funds, in the following manner: \$1000 each from Districts 2, 4 and 26, ~~and~~ \$500 each from Districts 1, 3, 6, 12, 15, 19, 22, 24 and 25; and \$250 each from Districts 14, 17, and 23; through the Office of Management and Budget, to the Waterfront Development Corporation for costs associated with the Louisville Waterfront 4th of July.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
