ORDINANCE NO. **SERIES 2019**

AN ORDINANCE CHANGING THE ZONING SINGLE-FAMILY RESIDENTIAL TO C-2 **COMMERCIAL** ON **PROPERTY** LOCATED AΤ BARDSTOWN ROAD CONTAINING 1.09 ACRES AND BEING IN LOUISVILLE METRO (CASE NO. 18ZONE1016) (AS AMENDED).

WHEREAS, The Legislative Council of the Louisville/Jefferson County Metro Government (the "Council") has considered the evidence presented at the public hearing held by the Louisville Metro Planning Commission and the recommendations of the Planning Commission and its staff as set out in the minutes and records of the Planning Commission in Case No. 18ZONE1016; and

WHEREAS, the Council concurs in and adopts the findings of the Planning Commission for the zoning change in Case No. 18ZONE1016 and approves and accepts the recommendations of the

Planning Commission as set out in said minutes and records, with an amended binding element.

NOW THEREFORE BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:

SECTION I: That the zoning of the property located at 4141 Bardstown Road containing 1.09 acres and being in Louisville Metro, as more particularly described in the minutes and records of the Planning Commission in Case No. 18ZONE1016, is hereby changed from R-4 Single-Family Residential to C-2 Commercial; provided, however, said property shall be subject to the binding elements as set forth in the minutes of the Planning Commission in Case No. 18ZONE1016-, with an amendment to the following binding element:

9. The existing wood fence along the northeast property line will shall be kept in good repair by the property owner of 4141 Bardstown Road.

SECTION II: This Ordinance shall take effect upon its passage and approval.
