AN ORDINANCE APPROVING A TEXT AMENDMENT TO THE LAND DEVELOPMENT CODE RELATING TO HEALTH CLUBS AND SIMILAR USES AND BEING IN LOUISIVLLE METRO (CASE NO. 19AMEND1004).

WHEREAS, the Louisville Metro Planning Commission held a public hearing on these amendments on June 6, 2019 and unanimously recommended approval of these amendments as they conform to the Guidelines of the Comprehensive Plan; and
