BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The sum of \$9,500 is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,500 from District 15; \$2,000 from District 21; \$1,000 from District 25; \$500 each from Districts 10, 12, 13, 14, and 24; and \$250 each from Districts 1 and 17; through the Office of Management and Budget, to South Louisville Community Ministries, Inc. for expenses associated with holding its Taste of South Louisville fundraising event.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of
