**SECTION I:** The Mayor is hereby authorized to enter into an agreement with the US Department of Interior to accept \$50,000 of National Park Service funds to conduct an in-depth research and field survey of Louisville's historic Chickasaw Neighborhood for consideration to be listed on the National Register of Historic Places.
