the zoning change in Case No. 19ZONE0013 and approves and accepts the recommendations of the

Planning Commission as set out in said minutes and records.

## NOW THEREFORE BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:

**SECTION I:** That the zoning of the property located at 1692 Mercer Avenue containing 0.125 acres and being in Louisville Metro, as more particularly described in the minutes and records of the Planning Commission in Case No. 19ZONE0013, is hereby changed from R-5 Residential Single Family to OR Office/Residential; provided, however, said property shall be subject to the binding elements as set forth in the minutes of the Planning Commission in Case No. 19ZONE0013.

**SECTION II:** This Ordinance shall take effect upon its passage and approval.
