O-325-19 19ZONE1013 Approval

**SECTION I:** That the zoning of the property located at 8101 Cooper Chapel Road containing 24.09 Acres and being in Louisville Metro, as more particularly described in the minutes and records of the Planning Commission in Case No. 19ZONE1013, is hereby changed from R-4 Residential Single Family to R-5 Residential Single Family; provided, however, said property shall be subject to the binding elements as set forth in the minutes of the Planning Commission in Case No. 19ZONE1013.
