SECTION I: The Mayor is hereby authorized to enter into an agreement with the Commonwealth of Kentucky Transportation Cabinet to accept the reallocation of \$100,000 from the right-of-way phase to the design phase of the Buechel Bank Road Widening Project. There is no change to the total project's budget.
