BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$30,400 \$43,200 \$54,400 from Neighborhood Development Funds in the following

manner: \$8,000 <u>each</u> from Districts <u>4 and</u> 23; <u>\$6,400 each from Districts 2 and 24;</u> <u>\$4,800 each from Districts 12 and 17;</u> \$3,200 each from Districts <u>7, 10,</u> and 11; and <u>\$1,600 each from Districts 1, 6, 9,</u> and 21; through the Office of Management and Budget, to Commonwealth Theatre Center, Inc., for programming expenses associated with performances of "Rumpelstiltskin."

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
