## , SERIES 2019 ORDINANCE APPROPRIATING \$46,000 IN NEIGHBORHOOD DEVELOPMENT AN FUNDS IN THE FOLLOWING MANNER: \$24,000 FROM DISTRICT 23; \$16,000 FROM DISTRICT 24; AND \$6,000 FROM DISTRICT 13; TO METRO PARKS FOR THE 2020 FRIDAYFEST CONCERT SERIES AT HIGHVIEW PARK

SPONSORED BY: COUNCIL MEMBERS PEDEN, FLOOD, FOX

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO **GOVERNMENT (THE COUNCIL) AS FOLLOWS:** 

SECTION I: The sum of \$46,000 is hereby appropriated from Neighborhood Development Funds in the following

manner: \$24,000 from District 23; \$16,000 from District 24; and \$6,000 from District 13; to Metro Parks for the 2020

FridayFest Concert Series at Highview Park.

SECTION II: The Council has determined that the funds requested in this Ordinance will be expended for a public

purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of

passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
