of Case No. 19-STRCLOSURE-0008, has recommended to the Legislative Council of the

Louisville/Jefferson County Metro Government (the "Council") that the first alley south of W.

Breckinridge Street between S. 2nd Street and S. 3rd Street and being in Louisville Metro be closed

because the closure complies with the Goals, Objectives and Plan Elements of the Comprehensive

Plan; and

WHEREAS, the Council concurs in and adopts the findings of the Planning Commission in Case No. 19-STRCLOSURE-0008 and approves and accepts the recommendation of the Planning

Commission as set out in said minutes and records.

## NOW THEREFORE BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:

**SECTION I:** That the first alley south of W. Breckinridge Street between S. 2nd Street and S.

3rd Street and being in Louisville Metro, as more particularly described in the minutes and records of

the Planning Commission in Case No. 19-STRCLOSURE-0008 and as shown on the attached alley

closure plat, be closed subject to all existing easements of record and all existing utility easements or

rights enjoyed by said utility companies as the result of being located in, on or over said right-of-way.

**SECTION II:** This Ordinance shall take effect upon its passage and approval.
