WHEREAS, the Metro Government wishes to enter into this agreement through Public Works & Assets.

BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The Mayor is hereby authorized to enter into an agreement with the Kentucky Fair Board and the Louisville/Jefferson County Visitors and Convention Commission to accept total funding of \$227,000 towards sidewalk improvements along Phillips Lane to enhance pedestrian safety and connectivity to the Kentucky Fair and Exposition Center.
