**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The amount of \$13,523 is hereby appropriated from Neighborhood Development Funds Districts 16 and 7, through the Office of Management and Budget, to the Jefferson County Public Education Foundation, Inc. for Phase 1 of the rubber surfacing of the playground for special needs students at Norton Elementary located at 8101 Brownsboro Road.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended

for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
