BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The amount of \$10,000 is hereby appropriated from the District 2 Neighborhood Development Fund, through the Office of Management and Budget, to the First Neighborhood Place to help seniors and low-income individuals financially with outstanding bills, necessary home repairs, and other similar financial issues.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
