## NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** Louisville Metro Council hereby resolves to retain the professional services of David Beyer to assist with the Government Oversight and Accountability Committee with the investigation adopted in Resolution No. 021, Series 2020. The contract for professional services with David Beyer is appropriate up to, but is not to exceed, \$30,000. David Beyer will conduct the investigation at the direction of the Chair (and Vice Chair in the Chair's absence) of the Government

Oversight and Accountability Committee and in compliance with Metro Council Rule 4A.04(b).

SECTION II: The Purchasing Department is hereby directed to process the attached contract

pursuant to Louisville Metro's standard policies and procedures.

**SECTION III:** This Resolution shall take effect upon its passage and approval.
