BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$8,250~~ ~~\$11,000~~ \$15,650 is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 12; ~~\$2,500 from Districts 14 and 25;~~ \$2,000 from Districts 13 and 14; \$1,000 from Districts 15 and 24; \$500 from Districts 10 and 23; and \$250 from Districts 19 and 21; \$150 from District 17, to Metro

Parks for the 2020 Riverview Independence Festival.

SECTION II: The Council has determined that the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
