BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$5,000 \$11,000 \$12,000 is hereby appropriated from Neighborhood Development Funds

in the following manner: <u>\$4,500 from District 21</u>; \$3,000 from District 15; \$1,000 from Districts 13 and 25; \$500 from Districts <u>3</u>, 10, <u>12</u>, and 14; and <u>\$250 from Districts 1 and 17</u>, through the Office of Management and Budget, to South Louisville Community Ministries, Inc. ("SLCM") for expenses associated with families helping families and supporting SLCM's emergency rental assistance.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
