BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

**SECTION I:** The sum of \$13,500 \$14,500 is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 13; \$2,250 from District 14; \$1,000 from Districts 12, 15, 23, and 25; \$500 from Districts <u>1</u>, 10, 21, <del>and</del> 22, <u>and 24</u>; \$250 from Districts 8, 9, and 17, to the Louisville Metro Parks Department for the 2020 Annual Forest Fest Bluegrass Music Festival to be held at the Jefferson Memorial Forest.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and

effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
