COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The amount of \$9,500 \$14,000 \$18,500 is hereby appropriated from Neighborhood Development Funds in the following manner: \$2,000 from District 4; \$1,500 <u>each</u> from Districts 3, 7, and 25; \$1,000 each from Districts 1, 2, 6, 7, 9, 10, <u>15, 20</u>, and <u>24</u> 25; and \$500 each from Districts <u>5, 13, 14, 19, 21</u>, and <u>23, and 26</u>; and \$250 each from Districts <u>17 and 22</u>; through the Office of Management and Budget, to the Waterfront Development Corporation for The Second Annual Juneteenth Jubilee in Waterfront Park.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
