## BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("THE COUNCIL") AS FOLLOWS:

**SECTION I:** The sum of \$17,500 is hereby appropriated from Neighborhood Development Funds in the following manner: \$12,500 from District 8 and \$5,000 from District 9, through the Office of Management and Budget, to Highland Commerce Guild to pay for graffiti abatement along commercial corridors.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
