ORDINANCE NO. _____, SERIES 2020

AN ORDINANCE APPROPRIATING \$13,000 FROM DISTRICT 3 NEIGHBORHOOD DEVELOPMENT FUNDS TO LOUISVILLE METRO PARKS AND RECREATION TO PAY \$3,000 IN ENTRY FEES TO ALGONQUIN PARK POOL FOR DISTRICT 3 RESIDENTS AND \$10,000 TO PROVIDE SECURITY SERVICES AT ALGONQUIN PARK THROUGH LABOR DAY.

SPONSORED BY: COUNCIL MEMBER DORSEY

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$13,000 is hereby appropriated from District 3 Neighborhood Development Funds to Louisville Metro Parks and Recreation to pay \$3,000 in entry fees to Algonquin Park Pool for District 3 residents and \$10,000 to provide security services at Algonquin Park through Labor Day.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SCTION IV: This Ordinance shall take effect upon its passage and approval.
