AN ORDINANCE REPEALING ORDINANCE NO. 051, SERIES 2020 WHICH APPROPRIATED \$6,000 FROM DISTRICT 6 NEIGHBORHOOD DEVELOPMENT FUNDS TO THE METRO PARKS DEPARTMENT TO PAY FOR THE COMMUNITY EVENT JAZZ IN CENTRAL PARK.

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: Ordinance No. 051, Series 2020 is hereby repealed which appropriated \$6,000 from District 6 Neighborhood Development Funds to the Metro Parks Department to pay for the Community Event Jazz in Central Park.

SECTION II: The Council has determined the funds requested in this Ordinance will be returned to the appropriate Districts' NDF account.

SECTION II: This Ordinance shall take effect upon its passage and approval.
