AN ORDINANCE RELATING TO THE ZONING OF PROPERTY LOCATED AT 10001 CEDAR CREEK ROAD CONTAINING APPROXIMATELY 58.03 ACRES AND BEING IN LOUISVILLE METRO (CASE NO. 20ZONE0005).

LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:

SECTION I: That the zoning of the property located at 10001 Cedar Creek Road containing

approximately 58.03 acres and being in Louisville Metro, as more particularly described in the

minutes and records of the Planning Commission in Case No. 20ZONE0005, is hereby changed from

R-4 Residential Single Family to R-5 Single Family; provided, however, said property shall be subject

to the binding elements as set forth in the minutes of the Planning Commission in Case No.

20ZONE0005.

SECTION II: This Ordinance shall take effect upon its passage and approval.
