WHEREAS, the Council concurs in and adopts the findings of the Planning Commission in Case No. 20STRCLOSURE0014 and approves and accepts the recommendation of the Planning

Commission as set out in said minutes and records.

NOW THEREFORE BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:

SECTION I: That the portion of an unnamed alley between Eastern Parkway and Hahn Street containing approximately 4,497 square feet and being in Louisville Metro, as more particularly described in the minutes and records of the Planning Commission in Case No. 20STRCLOSURE0014 and as shown on the attached road closing plat, be closed subject to all existing easements of record and all existing utility easements or rights enjoyed by said utility companies as the result of being located in, on or over said right-of-way; provided, however, said closure shall be subject to the condition of approval as set forth in the minutes of the Planning Commission in Case No. 20STRCLOSURE0014.

SECTION II: This Ordinance shall take effect upon its passage and approval.
