AN ORDINANCE APPROPRIATING 7,000 10,500 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: 5,000 FROM DISTRICT 22; AND 2,000 FROM DISTRICT  $21_{7}$ ; 1,000 FROM DISTRICT 2; 500 EACH FROM DISTRICTS 10, 14, 15, AND 25; AND 250 EACH FROM DISTRICTS 6 AND 17; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO C.H.O.I.C.E., INC. FOR THE DARE TO DREAM SPORTS LEADERSHIP AND MENTORING PROGRAM (AS AMENDED).

## BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("THE COUNCIL") AS FOLLOWS:

**SECTION I:** The sum of \$7,000 \$10,500 is hereby appropriated from Neighborhood

Development Funds in the following manner: \$5,000 from District 22; and \$2,000 from District 21,

\$1,000 from District 2; \$500 each from Districts 10, 14, 15, and 25; and \$250 each from Districts 6

and <u>17;</u> through the Office of Management and Budget, to C.H.O.I.C.E., Inc. for the Dare to Dream sports leadership and mentoring program.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
