FOR THE DARE TO DREAM SPORTS LEADERSHIP AND MENTORING PROGRAM (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("THE COUNCIL") AS FOLLOWS:

SECTION I: The sum of ~~\$7,000~~ \$10,500 is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 22; and \$2,000 from District 21,; \$1,000 from District 2; \$500 each from Districts 10, 14, 15, and 25; and \$250 each from Districts 6

and 17; through the Office of Management and Budget, to C.H.O.I.C.E., Inc. for the Dare to Dream sports leadership and mentoring program.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
