AN ORDINANCE APPROPRIATING ~~\$5,500~~ \$6,250 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$3,000 FROM DISTRICT 15; \$1,000 FROM DISTRICT 25; AND \$500 EACH FROM DISTRICTS 12, 13, AND 14 , AND 21; AND \$250 FROM DISTRICT 5; TO METRO PARKS FOR THE JACK-O'-LANTERN SPECTACULAR EVENT IN IROQUOIS PARK (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of ~~\$5,500~~ \$6,250 from Neighborhood Development Funds in the following manner: \$3,000 from District 15; \$1,000 from District 25; and \$500 each from Districts 12, 13, and 14 , and 21; and \$250 from District 5; to Metro Parks for the Jack-O'-Lantern Spectacular event in Iroquois Park.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for

a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
