**WHEREAS**, the Department of Public Works and Assets may accept \$130,000 from the Kentucky Regional Planning and Development Agency; and

**WHEREAS**, the Metro Government wishes to enter into this Agreement with Kentucky Regional Planning and Development Agency through the Department of Public Works and Assets.

**BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The Mayor is hereby authorized to enter into an Agreement and receive a stipend in the amount of \$130,000 from the Kentucky Regional Planning and Development Agency to support technical or professional planning/data collection services as indicated in the Kentucky Regional Planning and Development Agency's Fiscal Year 2021 Unified Planning Work Program, funded by grants from one or more of the following: the Federal Transit Administration, the Federal Highway Administration, the Kentucky Transportation Cabinet, and the Indiana Department of Transportation.

**SECTION II:** This Resolution shall take effect upon its passage and approval.
