\$17,800 AN ORDINANCE APPROPRIATING \$16,200 FROM **NEIGHBORHOOD** DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$6,800 \$4,000 FROM DISTRICT 12; \$2,400 EACH FROM DISTRICTS 17 AND 23; \$2,000 FROM DISTRICT 9; \$1,800 FROM DISTRICT 10; \$1,600 FROM DISTRICT 24; \$1,200 FROM DISTRICT 21; AND \$800 FROM DISTRICT 6; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET. TO COMMONWEALTH THEATER CENTER. INC TO VIRTUALLY STREAM "NATION IN CRISIS" TO SCHOOLS THROUGHOUT JEFFERSON COUNTY. (AS AMENDED) SPONSORED BY: COUNCIL **MEMBERS** PEDEN, WINKLER, FLOOD, HOLLANDER, MULVIHILL, BLACKWELL, GEORGE, AND PRESIDENT JAMES

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of \$17,800 \$16,200 is hereby appropriated from Neighborhood

Development Funds in the following manner: \$6,800 \$4,000 from District 12; \$2,400 each from

Districts 23 and 17; \$2,000 from District 9; \$1,800 from District 10; \$1,600 from District 24; <u>\$1,200</u> from District 21; and \$800 from District 6; through the Office of Management and Budget, to Commonwealth Theater Center, Inc. to virtually stream "Nation in Crises" to schools throughout Jefferson County.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
