a. <u>c.</u> The Middletown Library Branch will reopen no later than December 31, 2020 at 12556 Shelbyville Road with standard branch hours. <u>The Metro Council requests a report from the Louisville</u> <u>Free Public Library at a meeting of the Metro Council Budget Committee, no later than March 31,</u> 2021, to update the community on the progress of the project and its expected completion date.
