BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of \$20,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$15,000 from District 12 and \$5,000 from District 14, through the Office of Management and Budget, to Jefferson County Public Education Foundation to fund portions of a new playground at Johnsontown Road Elementary which will be open to the public and surrounding neighborhoods.
