AN **ORDINANCE** AMENDING **SEVERAL** SECTIONS OF THE COUNTY LOUISVILLE/JEFFERSON **METRO** GOVERNMENT CODE OF ORDINANCES ("LMCO") CHAPTER 161 RELATING TO THE REGULATION OF **NEIGHBORHOOD PLANS. (AS AMENDED)**

WHEREAS, a new comprehensive plan for Louisville Metro, Plan 2040, was adopted in 2019, which plan recommends an update to LMCO 161.02 to 161.09 (the "Neighborhood Plans Ordinance"); and

**WHEREAS**, Plan 2040's guiding C.H.A.S.E. principles (Connected, Healthy, Authentic, Sustainable and Equitable) create a more holistic approach to planning and development; and

**WHEREAS,** the neighborhood planning process is dynamic, and the current Neighborhood Plans Ordinance does not reflect current organizational structures and best practices; and

**WHEREAS**, the Legislative Council of the Louisville/Jefferson County Metro Government (the "Council") passed Resolution No. 82, Series 2020 on August 20, 2020, requesting a review of policies and procedures for more equitable and inclusive development; and

WHEREAS, the Office of Advanced Planning and Sustainability, with input from the Office of Planning and Design Services and Louisville Forward, has conducted this review, which included a review of various feedback received over the years on the various neighborhood and area plans, and has proposed the following amendments to the Neighborhood Plans Ordinance; and

**WHEREAS,** based on the review and the evaluation of the Neighborhood Plans Ordinance over time, it is appropriate to make amendments necessary to continue the effectiveness of the Neighborhood Plans Ordinance.

NOW THEREFORE BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:

**Section I:** The attached amendments to LMCO Sections 161.01 to 161.09 are hereby adopted and approved.

**Section II:** This Ordinance shall take effect upon its passage and approval.
