ORDINANCE NO. _____, SERIES 2021

AN ORDINANCE APPROPRIATING \$15,200 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$8,800 FROM DISTRICT 15 AND \$6,400 FROM DISTRICT 21, THROUGH PUBLIC WORKS, TO INTEGRATED SERVICES, INC. TO CONDUCT SPRING AND FALL LANDSCAPING SERVICES AT THE S. 3RD ST. AND TAYLOR BLVD. INTERCHANGE RAMPS AND THE S. 3RD ST. AND SOUTHERN PKWY. INTERCHANGE RAMPS.

SPONSORED BY: COUNCIL MEMBERS GEORGE AND TRIPPLETT

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of \$15,200 is hereby appropriated from Neighborhood Development Funds in the following manner: \$8,800 from District 15 and \$6,400 from District 21, though Public Works, to Integrated Services, Inc. to conduct Spring and Fall landscaping services at the S. 3rd St. and Taylor Blvd. interchange ramps and the S. 3rd St. and Southern Pkwy. Interchange ramps.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
