AN ORDINANCE APPROPRIATING \$15,200 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$8,800 FROM DISTRICT 15 AND \$6,400 FROM DISTRICT 21, THROUGH PUBLIC WORKS, TO INTEGRATED SERVICES, INC. TO CONDUCT SPRING AND FALL LANDSCAPING SERVICES AT THE S. 3<sup>RD</sup> ST. AND TAYLOR BLVD. INTERCHANGE RAMPS AND THE S. 3<sup>RD</sup> ST. AND SOUTHERN PKWY. INTERCHANGE RAMPS.

SPONSORED BY: COUNCIL MEMBERS GEORGE AND TRIPLETT

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

**SECTION I:** The sum of \$15,200 is hereby appropriated from Neighborhood Development

Funds in the following manner: \$8,800 from District 15 and \$6,400 from District 21, though Public

Works, to Integrated Services, Inc. to conduct Spring and Fall landscaping services at the S. 3<sup>rd</sup> St.

and Taylor Blvd. interchange ramps and the S. 3<sup>rd</sup> St. and Southern Pkwy. Interchange ramps.

SECTION II: The Council has determined the funds requested in this Ordinance will be

expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and

effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
