AN ORDINANCE APPROPRIATING \$15,000 FROM DISTRICT 8 NEIGHBORHOOD FUNDS. OFFICE DEVELOPMENT THROUGH THE OF MANAGEMENT AND BUDGET, TO TREESLOUISVILLE, INC. TO FUND THE CREATION OF SIDEWALK TREE WELLS PLANTING CUTS FOR FOR THE OF 100 TREES ALONG BARDSTOWN ROAD BETWEEN EASTERN PARKWAY AND LONGEST AVENUE. SPONSORED BY: COUNCIL MEMBER CHAMBERS ARMSTRONG

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of \$15,000 is hereby appropriated from District 8 Neighborhood

Development Funds, though the Office of Management and Budget, to TreesLouisville, Inc. to fund

the creation of sidewalk cuts for tree wells for the planting of 100 trees along Bardstown Road

between Eastern Pkwy and Longest Ave.

SECTION II: The Council has determined the funds requested in this Ordinance will be

expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and

effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
