## LOUISVILLE/JEFFERSON COUNTY METRO AS FOLLOWS:

**SECTION I:** Pursuant to Louisville Metro Code of Ordinances § 39.033, and in recognition of the Bradley family's contributions to Louisville/Jefferson County Metro Government Parks, the Clifton Heights Greenway shall henceforth be designated the Clifton Heights Bradley Greenway. The Department of Metro Parks is directed, in conjunction with other necessary Metro Agencies, to move forward with the fabrication and installation of all necessary signage upon the passage of this Resolution and upon the receipt of all necessary funds to cover such expense.

**SECTION II:** This Resolution shall take effect upon its passage and approval.
