ORDINANCE NO. _____, SERIES 2021

AN ORDINANCE APPROPRIATING \$3,750 \$15,750 \$18,750 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$1,500 EACH FROM DISTRICTS 2, 6, 7, 8, 10, 12, 14, AND 17, 19, 20, AND 23; AND \$750 FROM DISTRICT 9; AND \$375 EACH FROM DISTRICTS 13, 15, 21, 25; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO KENTUCKY SHAKESPEARE, INC FOR THE SHAKESPEARE IN THE PARKS *ROMEO AND JULIET* 2021 TOUR (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS: **SECTION I:** The sum of \$3,750 \$15,750 \$18,750 from Neighborhood Development Funds in the following manner: \$1,500 each from Districts 2, 6, 7, 8, 10, 12, 14, and 17, 19, 20, and 23; and \$750 from District 9; and \$375 each from Districts 13, 15, 21, 25; through the Office of Management and Budget, to Kentucky Shakespeare, Inc. for the Shakespeare in the Parks *Romeo and Juliet* 2021 tour.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
