WHEREAS, the Legislative Council of the Louisville/Jefferson County Metro Government (the

"Council") has considered the evidence presented at the public hearing held by the Louisville Metro

Planning Commission (the "Planning Commission") and the recommendations of the Planning

Commission and its staff as set out in the minutes and records of the Planning Commission in Case

No. 20ZONE0034; and

WHEREAS, the Council concurs in and adopts the findings of the Planning Commission

denying the zoning change in Case No. 20ZONE0034 and approves and accepts the recommendation of the Planning Commission as set out in said minutes and records.

## NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:

**SECTION I:** That the zoning of the properties located at 11800 and 11908 E Orell Road and 11705 Dixie Highway containing approximately 6.15 acres and being in Louisville Metro, as more particularly described in the minutes and records of the Planning Commission in Case No. 20ZONE0034, is hereby maintained as R-4 Residential Single Family.

**SECTION II:** This Ordinance shall take effect upon its passage and approval.
