BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of ~~\$4,950~~ \$5,450 ~~\$6,000~~ is hereby appropriated from Neighborhood Development Funds in the following manner: \$2,500 from District 9; \$500 each from Districts 10, 12, and 22; \$250 each from Districts 6, 14, 15, 17, 18, 20, and 25; and \$200 from District 21; and \$50 from District 19; through the Office of Management and Budget, to St. Joseph Catholic Orphan Society dba St. Joseph Children's Home for costs associated with security for the annual St. Joseph Children's Home picnic.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
