TO SUPPORT THE TASTE OF LOUISVILLE FUNDRAISER (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (“THE COUNCIL”) AS FOLLOWS:

SECTION I: The sum of ~~\$2,000~~ \$6,500 ~~\$\$\$9,500~~ is hereby appropriated from District 24 Neighborhood Development Funds; in the following manner: \$2,000 each from Districts 15 and 21;

\$1,000 each from Districts 4, 12 and 13; and \$500 each from Districts 10, 14, 19, 22, and 25; through the Office of Management and Budget, to South Community Ministries, Inc. to support the Taste of Louisville fundraiser.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council’s Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
