AN ORDINANCE APPROPRIATING \$11,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$3,666.68 FROM DISTRICT 14; AND \$3,666.66 EACH FROM DISTRICTS 12 AND 25; TO THE LOUISVILLE METRO POLICE DEPARTMENT TO ASSIST WITH OVERTIME HOURS FOR THE 3<sup>RD</sup> DIVISION TO PATROL STREETS DUE TO EXCESS SPEEDING AND DIRT BIKE USE.

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("THE COUNCIL") AS FOLLOWS:

**SECTION I:** The sum of \$11,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,666.68 from District 14; and \$3,666.66 each from Districts 12 and 25; to the Louisville Metro Police Department to assist with overtime hours for the 3<sup>rd</sup> Division to patrol streets due to excess speeding and dirt bike use.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
