TO PAY FOR EXTENSIVE ACTIVITY BASED CURRICULUM MATERIALS (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of ~~\$4,500~~ \$12,750 \$20,500 from Neighborhood Development Funds in the following manner: \$4,000 each from Districts 4 and 22; \$2,000 from District 19; \$1,500 from District 13; \$1,000 each from Districts 2, 4, 14, 15, and 17, and 19; \$750 from District 21; \$500 each from Districts 1, 5, 6, 7, 24, and 25 14, and 21; and \$250 each from Districts 9, 10, 12, 16, and 20; through the Office of Management and Budget, to Junior Achievement of Kentuckiana Inc. to pay for extensive activity based curriculum materials.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
