**SECTION I:** The following appropriation for the listed contract is hereby approved:

\$1,634,859.00 \$1,715,051.00 for a noncompetitively negotiated Professional Service Contract with Seven Counties Services, Inc. for professional services regarding deflection program mobile response efforts from December 6, 2021 through December 5, 2022.

**SECTION II:** Louisville Metro Government agrees that Metro Safe shall provide monthly reports to the Council with updates on the number of positions staffed and the compensation for same under the Contract.
