AN ORDINANCE APPROPRIATING \$30,000 \$40,000 FROM DISTRICT 9 NEIGHBORHOOD DEVELOPMENT FUNDS TO DEVELOP LOUISVILLE FOR EXPENSES RELATED TO DEVELOPING A NEIGHBORHOOD PLAN FOR THE CLIFTON AND CRESCENT HILL NEIGHBORHOODS (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("THE COUNCIL") AS FOLLOWS:

SECTION I: The sum of \$30,000 \$40,000 is hereby appropriated from District 9 Neighborhood Development Funds to Develop Louisville for expenses related to developing a neighborhood plan for the Clifton and Crescent Hill neighborhoods.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
